Visa Application Procedure for Students from Africa to study in Thailand

Application is made on a Non-immigration ED visa (Non-ED)

If you are a newly recruited student

(1) Letter of acceptance from the receiving school/university or institute in Thailand signed by the authorized person. The letter must be attached with a copy of passport/ID card of the one who signs the letter.

(2) A copy of school/ university registration certificate/license of the receiving school/university in Thailand. This requirement is applicable for only private school/university in Thailand.

(3) Letter of approval from the Ministry of Education of Thailand.

(4) Letter of sponsorship or letter of self-sponsorship.

If you are self-sponsored – Your own bank statement for the last 6 months issued by the authorized bank officer/manager. The applicant is required to have a fund of equivalent 200 USD for each day staying in Thailand. The equivalent amount of 800 USD is a minimum requirement.

If you are sponsored by someone else – The bank statements of both yourself and your sponsor for the last 6 months issued by the authorized bank officer/manager. The applicant is required to have a fund of an equivalent 200 USD for each day staying in Thailand. The equivalent amount of 800 USD is a minimum requirement

(5) A copy of course syllabus

(6) Copy of the latest degree certificate and transcript of your previous institution

Visa regulations for Nigerian nationals holding the Ordinary Passport.

Nigerian nationals who have permanent residence in the foreign country where a Thai Embassy \slash

Consulate - General is situated, they can apply for a visa in that country. In this case, the applicants are not required to present the Certificate of Clearance issued by the National Drug Law Enforcement Agency of Nigeria.

Nigerian nationals whose permanent residence are in the foreign country where no Thai Embassy /Consulate - General is located, they have to file their visa application at the Royal Thai Embassy in Abuja. In this regard, they are required to submit the Certificate of Clearance as one of required documents in support of visa application.

Nigerian nationals who have permanent residence in Nigeria or in other countries which are under jurisdiction of the Royal Thai Embassy in Abuja; namely, Benin, Cameroon, Republic of the Congo, Central African Republic, Equatorial Guinea, Ghana and Sao Tome & Principe must make their visa application in person only at the Royal Thai Embassy in Abuja. In this case, they are required to present the Certificate of Clearance as one of required documents. This is to comply with the request of Nigerian authorities in order to prevent Nigerian drug traffickers from entering Thailand. Details of required documents are shown in Appendix 1.

Nigeria: Procedure for visa application.

Nigerian applicants have to carefully read and observe the above-mentioned visa regulations. They need to complete a visa application form and present it together with all required documents shown in Appendix 1.

The Embassy will not accept any incomplete visa application. Therefore, the applicants should check these required documents before their submission. In some cases, The Embassy reserves the rights to request additional documents as deemed necessary. The submission of all required documents does not guarantee the issuance of visa.

After examining the authenticity of these required documents, the Embassy will invite the applicants for interview.

The successful applicants have to pay for visa fee according to Non-Immigrant visa (Student visa) for which they apply. The visa fee is non-refundable.

It takes 2(two) working days to process a visa after the Embassy has obtained the complete supporting documents from the applicants.

Additional suggestion

The submission of forged documents as part of visa application process is a criminal offence under the Nigerian Criminal Code.

Any applicant who has committed such an act will be placed on the black list and reported to competent Nigerian authorities for further action.

<u>APPENDIX 1</u> <u>Supporting documents for Nigerian passport holders</u>

Original passport valid for not less than 6 months from the date of arrival in Thailand and blank pages.

Completed and signed application form.

Four (4) recent (2 x 2 inches) photographs (taken within the last 6 (six) months).

The Certificate of Clearance from the National Drug Law Enforcement Agency of Nigeria (NDLEA).

Certificate of Criminal Clearance issued by the Nigerian police and certified by the Notary Public or the Court and the Ministry of Foreign Affairs of Nigeria.

The original bank statement (for the last 12 months) and the letter of reference issued by the authorized bank officer/manager. The two documents must be certified by the Notary Public or the Court and the Ministry of Foreign Affairs of Nigeria. A copy of each document needs to be submitted.

Letter of reference from the company is required to be presented if the applicant is an employee stating the applicant's position, present salary, and duration of work service in the company. If the applicant is self – employed, relevant documents such as business license, financial status/evidence and tax income clearance must be submitted. For other occupations, relevant documents must be also presented.

International Health Certificate on Yellow Fever Vaccination. Birth Certificate of the applicant and one (1) copy of the Birth Certificate certified by the Court.

Reservation of a hotel in Thailand or address and telephone number of the sponsor/guarantor in Thailand. In the latter case, his/her financial status/evidence is required to be presented. This will be University accommodation

Reservation of the return air ticket or the return air ticket paid in full. Visa fee in amount of 4700 Naira.

Visa regulations for nationals of Cameroon, Republic of the Congo and Ghana.

The above – mentioned nationals are required to apply for an appropriate visa prior to entering

Thailand. They have to complete a visa application form and present it together with all required documents shown in <u>Appendix 2.</u>

The Embassy will not accept any incomplete visa application. Therefore, the applicants should check these required documents before their submission. In some cases, The Embassy reserves the rights to request additional documents as deemed necessary. The submission of all required documents does not guarantee the issuance of visa.

If the Embassy is satisfied with the required documents, the applicants will be asked for interview.

Should visas be granted, the applicants have to pay for visa fee according to the Non-Immigrant visa (Student visa) for which they apply. The visa fee is non-refundable.

It takes 2 (two) working days to process a visa after the applicants have submitted the complete visa application.

APPENDIX 2

Supporting documents for Cameroonian, Congolese and Ghanaian passport holders

Original passport valid for not less than 6 months from the date of arrival in Thailand and blank pages.

Completed and signed application form.

Two (2) recent (2 x 2 inches) photographs (taken within the last 6 (six) months).

Certificate of Criminal Clearance issued by the police and certified by the Notary Public or the Court and the Ministry of Foreign Affairs or the Embassy of these countries.

The original bank statement (for the last 12 months) and the letter of reference issued by the authorized bank officer/manager. The two documents must be certified by the Notary Public or the Court and the Ministry of Foreign Affairs or the Embassy of these countries. A copy of each document needs to be submitted.

Letter of reference from the company is required to be presented if the applicant is an employee stating the applicant's position, present salary, and duration of work service in the company. If the applicant is self – employed, relevant documents such as business license, financial status/evidence and tax income clearance must be submitted. For other occupations, relevant documents need to be presented.

International Health Certificate on Yellow Fever Vaccination.

Reservation of a hotel in Thailand or address and telephone number of the sponsor/guarantor in

Thailand. In the latter case, his/her financial status/evidence is required to be presented. This will be the University Accommodation

Reservation of the return air ticket or the return air ticket paid in full. Visa fee in amount of 4700 Naira.
